Denver Urban Semester Information

Teacher candidates who wish to student teach in an urban setting, may find the perfect opportunity in **Denver, Colorado**. Hope College is part of a consortium of colleges that arranges for social work internships and student teaching placements in this beautiful city. The Denver Urban Semester (DUS) program is administrated by Northwestern College in Iowa. Teacher candidates interested in this possibility should read on for further information:



Information

Application Procedures

- Teacher candidates interested in student teaching in Denver should contact the Director of Student Teaching & Certification in the Education Department to discuss the request for an off-campus student teaching placement. Teacher candidates are advised to seek this information as early in their programs as possible, but no later than <u>two semesters</u> prior to student teaching.
- Teacher candidates interested in this option will further need to submit a proposal to the Education Department, care of the Director of Student Teaching & Certification. The letter should state the specific request, the suggested location(s), and reasons for making the request. Letters, as well as the teacher candidate's DegreeWorks evaluation, should be submitted by the following due dates:
 - October 1st for Fall semester student teaching placements
 - February 1st for Spring semester student teaching placements
- Placement proposals will then be presented to the Education Department faculty for final approval.
- Among the conditions that the Department will consider will be the efficacy and quality of the
 placement proposal, the teacher candidate's academic standing, recommendations from the
 student's major academic department, clinical experience recommendations and demonstration of
 personal and professional dispositions.

Applications

- Teacher candidates will complete <u>three application forms</u> one for permission to student teach offcampus (Hope College Off-Campus Study Application), one for The Denver Urban Semester program, and one for approval to student teach (Education Department's application).
 - The <u>Off-Campus application form</u> is available online through the Fried International Center on campus at <u>www.travel.hope.edu</u>.
 - When completing this application, care should be taken to construct a well-written
 rationale that outlines why a Denver Urban Semester student teaching placement will
 be more beneficial than a West Michigan placement. Teacher candidates should also
 connect the Denver Urban Semester experience with career aspirations and/or the
 need to be off-campus.

<u>http://www.hope.edu/academic/education/studteach/student_teaching_application.html</u>. Application forms will be discussed at mandatory meetings held on campus each semester prior to due dates.

<u>Caveats</u>

- If the request is approved, teacher candidates must continue to meet <u>all</u> requirements to student teach at all times leading up to and including the start of the student teaching experience. Should the teacher candidate fail to meet said requirements, permission to student teach off-campus will be withdrawn and the off-campus student teaching placement will be cancelled.
- Student teachers who fail to remain in good standing with the College or enter the student teaching
 placement on probationary status will not be allowed to student teach in an off-campus location.

- The teacher candidate should be aware that there is no guarantee that a suitable student teaching placement can be secured. Although deliberate efforts will be made to make the placement, there may be circumstances beyond the control of the Education Department that prevent the placement from coming to fruition. Finding appropriate placements can be complex and the Education Department reserves the right to terminate the off-campus placement process when concerted efforts have not yielded a student teaching placement that meets all departmental and/or state requirements. If this occurs, the teacher candidate would then be required to complete the student teaching experience within the immediate area of Hope's campus.
- Teacher candidates should also be aware that the College may place limits on the number of students that may be off-campus in any one semester. The teacher candidate interested in an offcampus option will need to apply for and be approved by the College to be off-campus for the student teaching semester.
- Teacher candidates seeking off-campus student teaching placements should understand that this is
 a serious decision and commitment. While the student is encouraged to enjoy the travel experience,
 s/he must understand that the commitment to student teach is his/her primary concern and
 responsibility. As such, student teachers must meet the highest standards for professional
 preparation, personal/psychological readiness and spiritual maturity.
- Although rare, there are times when an off-campus student teaching placement may be cancelled by the College at the last minute for reasons of health and/or safety. It should be understood that Chicago Semester defers to the decisions of the College.

Deadlines

For FALL semester student teaching placements:

- Off-Campus Application:
 - <u>February 1st</u>: <u>Off-campus</u> applications for the Fall semester are due to the International Education Office by February 1st. The application can be accessed at: www.travel.hope.edu.
- Denver Urban Semester Center Application:
 - February 10th/May 1st: Denver Urban Semester applications
 - (<u>https://www.nwciowa.edu/academics/off-campus-programs/denver-urban-semester</u>) will be due by **May 1**st for the following Fall semester. However, teacher candidates are advised to submit their applications no later than **February 10**th in order to enhance admittance to the program.
- <u>Student Teaching Application-Education Department:</u>
 - First Friday in November:
 - Education Department Student Teaching Applications are due the first Friday in November for student teaching placements the following Fall semester.
 - Students should note their preference to student teach in Denver Urban Semester in the "Comments" section of the Student Teaching application.

For SPRING semester student teaching placements:

- Off-Campus Application:
 - October 1st: Off-campus applications for the Spring semester are due to the International Education Office by October 1st. Permission to leave campus for the Spring semester may be limited. The application can be accessed at: www.travel.hope.edu.
- Denver Urban Semester Center Application:
 - October 1st/February 10th: Denver Urban Semester applications
 (https://www.nwciowa.edu/academics/off-campus-programs/denver-urban-semester) will be due by October 1st for the following Spring semester. However, teacher candidates are strongly encouraged to submit their applications no later than February 10th of the previous semester in order to enhance admittance to the program.

Student Teaching Application-Education Department:

- First Friday in March:
 - <u>Student Teaching Applications</u> for the following <u>Spring semester</u> are due by the <u>first</u> <u>Friday in March</u>.
 - Students should note their preference to student teach in the Denver Urban Semester program in the "Comments" section of the Student Teaching application.

Conditions of Approval:

Because the off-campus student teacher is at additional risk, the Education Department carefully screens each student teacher who desires an off-campus student teaching experience. Candidates must be in good standing and have exhibited strong professional skills and dispositions in all coursework and field experiences. In addition, the institution and school system may screen potential student teachers and reserve the right to reject a student teaching candidate.

- Student teachers must be in good standing with the College prior to and at the point of student teaching. Any teacher candidate who has been sanctioned or is restricted from participating in offcampus programs, will <u>not</u> be allowed to student teach off-campus.
- In order to student teach in an off-campus placement, teacher candidates must receive approval from the Education Department. Approvals typically take place in the semester prior to the student teaching experience, but remain contingent upon consistent demonstration of positive professional and personal dispositions, as well as successful performance in Education coursework and clinical experiences up to the point of student teaching.
- Any teacher candidate who fails to meet all performance requirements (e.g., minimum of C+ or higher in Education courses) and/or fails to receive a positive endorsement (e.g., "Highly Recommended" or "Recommended") from clinical experience mentors, will not be allowed to student teach off-campus.
- Student teachers wishing to student teach off-campus must meet a higher threshold for the Department's GPA requirements. The off-campus student teacher will be required to hold a GPA of 3.0 or higher in each of the following four areas:
 - o Överall
 - o Major
 - Minor
 - Education
- In addition, student teachers must receive a positive endorsement from his/her major department of study. Again, failure to secure a recommendation of "Highly Recommended" or "Recommended" from the major department of study will result in a denial to student teach off-campus.
- Teacher candidates who have been approved to student teach on probationary status will <u>not</u> be allowed to student teach in an off-campus placement.
- The school system where a student teacher is placed has the right to reject a candidate if said individual has <u>any</u> criminal convictions within the past seven (7) years and/or is not cleared by a criminal background check.

Off-Campus Study Application

 Teacher candidates planning to student teach through the Denver Urban Semester program must complete ALL portions the Off-Campus Study Application process through the International Education Office. This will include providing contact information, liability documents and student responsibility documents.

On-Site Visitation

Because of the distance between Hope College and Denver, teacher candidates are not required to
visit the Denver Urban Semester prior to arriving for the student teaching experience. However, the
program welcomes visitors and encourages students, including prospective student teachers, to
contact them and consider a short visit prior to the scheduled arrival.

Orientation

 The Denver Urban Semester provides an orientation program the first week that student teachers arrive for the semester's experience. During this time, student teachers become acclimated to the city, meet other students in the program, and secure housing for the semester.

Dates of Placements

- <u>Fall semester</u> student teachers begin their experiences in late August in Denver. They are <u>not</u> on Hope's campus at all during the semester. The placement extends to the final day of Exam Week.
- <u>Spring semester</u> student teachers begin their experiences in early January, at the start of the Spring semester. They are <u>not</u> on Hope's campus at all during the semester. The placement extends to the final day of Exam Week, though student teachers usually return to campus in time for graduation activities in May.

Priority for Placements

- Priority is given to student teachers who require a <u>single</u> student teaching placement. Student teachers with double student teaching placements may have more difficulty being accepted and placed.
- <u>Special Education majors</u> should consider the Denver Urban Semester student teaching option during the *Spring semester*. This is due to required courses that are only offered during the Fall semester on campus.

Placement Information

Most student teaching placements are made in Denver Public Schools, although at times, placements are made in private, parochial or charter school settings. The student teacher's résumé and transcript <u>will</u> be sent to each potential placement. As such, it is <u>imperative</u> that the résumé is error-free and well-written. All student teaching résumés <u>must</u> be submitted to the Handshake website for a review process. Details will be provided at mandatory student teaching meetings held each semester.

Student Teaching Seminar/Assignments

- Teacher candidates, who have been approved for an off-campus placement, will be <u>required</u> to attend several of the Wednesday evening Student Teaching Seminar sessions during the semester <u>prior</u> to the student teaching placement. The Seminar meets on Wednesday evenings from 5:00-6:30 p.m. The Director of Student Teaching & Certification will provide a calendar with the required sessions. Although the teacher candidate will not be officially enrolled in the Seminar during this semester, the required sessions provide important and pertinent information that the teacher candidate will miss while off-campus the following semester.
- The Denver Urban Semester student teacher will also attend a required Student Teaching Seminar while in Denver and will hand in required seminar assignments to DUS personnel over the course of the student teaching semester.

Coursework in Denver Urban Semester

In addition to the weekly Student Teaching Seminar, the Denver Urban Semester student teacher will be *required* to audit the Urban Cross-Cultural Course which meets on Friday afternoons. The student teacher will also need to determine how to complete requirements for EDUC 500-Educational Perspectives and the College's required Senior Seminar. Student teachers who remain on Hope's campus generally take these two courses throughout the semester while student teaching. However, student teachers involved with the Denver Urban Semester have the option of taking the senior seminar on-site, but not EDUC 500-Educational Perspectives. (NOTE: Although it is possible to take the Senior Seminar in Denver while student teaching, it is *strongly* recommended that the student teacher consider fulfilling this requirement outside of the student teaching semester.)

The following options are available for the Denver Urban Semester student teacher:

EDUC 500-"Perspectives in Education"/ "Education and Difference"

- Student teachers may take EDUC 500 as an independent study while student teaching. They meet
 with the course instructor during the previous semester and/or over the summer. Student teachers
 can complete course requirements either prior to leaving or during the student teaching semester.
 Student teachers must earn a C+ or higher in this course. If the student teacher opts to complete the
 EDUC 500 requirement prior to leaving for Denver Urban Semester, s/he can then complete the senior
 seminar requirement as part of the Denver Urban Semester's program.
- It is also possible for the student teacher to complete EDUC 500 in the once-a-week course format the semester <u>prior</u> to the student teaching semester. This would require having time available Wednesday afternoons during that semester <u>and</u> permission of the course instructor. Again, if the student teacher opts to complete the EDUC 500 requirement prior to leaving for Denver Urban Semester, s/he could then complete the senior seminar requirement in Denver Urban Semester.

The Senior Seminar

- The senior seminar <u>cannot</u> be completed as an independent study. It must either be completed <u>prior</u> to leaving for the Denver, while student teaching in Denver <u>or</u> upon return to campus following the student teaching experience.
 - If the student teacher wishes to complete it prior to leaving or upon a return to campus, s/he may enroll in any full-semester senior seminar (any 450+ level IDS course). The Senior

Seminar requirement can also be met in a number of off-campus programs (e.g., Vienna Summer School, Hope Comes to Watts May Term, Rosebud Indian Reservation May Term) during May, June and July terms. In any case, the senior seminar may be completed prior to leaving for or upon a return to campus following the student teaching experience.

 For those unable to enroll in a senior seminar prior to the student teaching semester, an option is available at the Denver Urban Semester program where student teachers dually enroll in the "Urban Cross-Cultural" and "Urban Leadership" courses. While this is an option for student teachers in Denver, it does create additional demands on the student teacher. Student teachers may find that the workload of these courses, along with preparation for the classroom, to be quite challenging. The student teacher is urged to consider taking the senior seminar outside of the student teaching experience in Denver if possible.

Options for Completing Coursework

- <u>Option 1:</u> ED500 is taken the semester prior to student teaching and the Senior Seminar is taken in the Denver Urban Semester program during the student teaching experience.
- Option 2: The Senior Seminar is taken in a semester other than the student teaching semester (prior to or following) and EDUC 500 is taken during the student teaching experience in Denver.
- <u>Öption 3</u>: EDUC 500 is taken as an independent study prior to student teaching and the Senior Seminar is taken in the Denver Urban Semester program during the student teaching experience.
- <u>Option 4</u>: Both ED500 and the Senior Seminar are taken during the student teaching experience in the Denver Urban Semester program (not recommended).

Registration

 Once teacher candidates have been approved for off-campus study, the Registrar's office will register student teachers for their coursework. Students will be registered for IDS747-02 for 13-16 credit hours (depending on what coursework the student will be completing in Denver Urban Semester). Hope's Registrar will then work out the details for student teaching, Student Teaching Seminar, Senior Seminar and EDUC 500 credits.

Certification Requirements

The student teacher should plan to be in contact with the Director of Student Teaching & Certification throughout the previous semester in order to submit appropriate materials for certification in a timely and accurate manner. All certification materials <u>must</u> be submitted <u>PRIOR</u> to leaving campus, unless the student teacher plans to return to Hope after the Denver Urban Semester student teaching experience.

Housing/Amenities

- The Denver Urban Semester provides housing for its students. The houses come furnished, but teacher candidates need to provide their own linens and towels. The houses have a kitchen, laundry room, living, dining and family rooms. Students are expected to maintain a tidy space and contribute to weekly "deep cleaning" responsibilities.
- Student teachers pay Denver Urban Semester directly for housing. Housing includes all utilities, internet, washer and dryer, storage and all furnishings and kitchen essentials. Student teachers receive an invoice that can be presented to the Financial Aid Office in time to receive funding if applicable.

Transportation

- As one of the cross-cultural learning tools, each student teacher will be invited to take public transportation (bus & light rail) each day to the student teaching site. Bus passes cost \$99/month and tuition will pay for the monthly bus fare.
- Student teachers are discouraged from having a car in Denver, though special circumstances might
 make this necessary. City parking is extremely limited and the DUS houses only have three permitted
 spaces for cars.

Food

 The student teacher is responsible for his/her own cooking and food purchases. DUS suggests budgeting \$50-\$60 a week. The DUS housing is located within close proximity to a number of grocery stores and several local farmers markets.

Community/Cultural Engagement

- DUS believes that part of learning comes from being in the community. As such, DUS schedules
 required events each weekend that allow the teacher candidate to experience people in the city that
 carry a range of worldviews.
- Tuition provides each teacher candidate with \$50 a month and \$200 a semester to enjoy these learning experiences.

Housing Expectations/Social Expectations

- Students are expected to follow the same housing and social expectations one would have living in campus housing.
- Visitors need to be approved to stay in the either of the DUS houses, by both the RD and Director, two weeks in advance.
- Although legal in Denver, any use of any form of marijuana, is strictly prohibited. Students who do not
 adhere to this rule are required to face disciplinary procedures from their college or university and will be
 required to leave Denver and the DUS program.
- Likewise, students are not allowed to bring alcohol into a DUS house. Students who do not adhere to
 this requirement will be required to face disciplinary procedures from their college or university and
 could be asked to leave the DUS program.

<u>TB Test</u>

Student teachers may need to provide proof of a current, negative TB test to Denver Urban Semester at the beginning of the student teaching experience.

Criminal Background Check

 Student teachers will need to submit to a criminal background check in Colorado. Details will be provided by the Denver Urban Semester personnel.

Tuition Waivers

 Teacher candidates who are eligible for tuition waivers should check with the Financial Aid Office to see if they be able to use this option for the Denver Urban Semester Center program.


Financial Aid

 Teacher candidates should check their financial aid packages with the Financial Aid Office prior to committing to the off-campus program.

Expectations

As always, it will be important for the student teacher to remember that permission to student teach in an off-campus placement is a *privilege, not a right*. The student teacher must, at all times, be cognizant that s/he is representing Hope College while in this placement. Therefore, expectations for professional behavior, dress and conduct remain high and are maintained for <u>all</u> student teachers, but particularly for those in an off-campus placement.
